

### Enrollment Report (Nov. 25, 2014)

### More than 25,000 Marylanders have enrolled for 2015 coverage

As of Nov. 24, 2014, more than 25,000 Marylanders have enrolled in quality and affordable health coverage since the open enrollment period began on Nov. 15.

With the successful launch of the upgraded MarylandHealthConnection.gov website, 25,780 individuals have enrolled, including 14,749 enrolled in qualified health plans and 11,031 in Medicaid. From Nov. 15 to Nov. 24, 32,744 consumer accounts were created; 29,546 calls were made to the Consumer Support Center, and 79,681 visited the application portal on the website.

# 2014 Enrollment Update

As of Nov. 14, 2014, 83,410 Marylanders enrolled in qualified health plans for coverage during calendar year 2014, up from 81,091 on Sept. 20.

#### **Medicaid Enrollment**

Medicaid has recorded a net increase of 190,975 enrollees from Dec. 31, 2013 to Nov. 25, 2014, for a total enrollment of 1,227,257. This figure takes into account that individuals may gain or lose Medicaid coverage because of changes in household, age, and income, as well as redeterminations.

Using the new and improved website, 11,031 Marylanders have signed up for Medicaid coverage since November 15. Some of these individuals may have already had Medicaid coverage, in which case the new system will renew their coverage.
